**TERMS AND CONDITIONS**

1. Information on how to register and participate form part of these Terms and Conditions. Registration and participation in this event are deemed acceptance of these Terms and Conditions.
2. Bookings are essential, and spaces are limited to 10 Participants per session.
3. Participation is only suitable for children aged 2 years old and over.
4. Parents/guardians/carers must be in attendance and supervise Participants for the duration of the Event.
5. Bookings must be made on behalf of Participants by parents/guardians/carers on the corresponding Humanitix Event pages, accessible via:

6. All materials and equipment will be supplied for the Event and on arrival parents/guardians/carers of Participants will receive one (1) complimentary small coffee card redeemable at the stores listed on the card.
7. On arrival, parents/guardians/carers of Participants must show their ticket and proof of ID. If parents/guardians/carers refuse or are unable to show proof of registration or ID they will be deemed ineligible to participate.
